RESOLVED, to declare Appropriation Ordinance No. 39 S. 2023 of the Municipality of Cordon, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of Republic Act No. 7160 and subject further to the following condition:

1. The grant of Performance Based Bonus (PBB) in the amount of Two Million Five Hundred Forty Four Thousand Six Hundred Sixty Seven Pesos & 95/100 (P2,544,667.95) shall be in accordance with IATF on the Harmonization of National Government Performance Monitoring, Information and Reporting Systems Memorandum Circular No. 2022-1, dated March 24, 2022, on the Guidelines on the Grant of the Performance-Based Bonus (PBB) for Fiscal Year 2022 under Executive Order No. 80, s., 2012 and Executive Order No. 201, s. 2016 and DILG-DBM Joint Memorandum Circular No. 2021-01, dated November 22, 2021 as amended by DILG-DBM Joint Memorandum Circular No. 2023-01, dated August 4, 2023;
2. The appropriation for the following account should be properly classified to specific Object of Expenditure and account code in accordance with COA Circular No. 2015-009 dated December 1, 2015, on Prescribing the Revised Chart of Accounts for LGUs:
