THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 40 S. 2023 of the Municipality of Cordon, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of Republic Act No. 7160 and subject further to the following condition:

1. The appropriation for the grant of Collective Negotiation Agreement (CNA) in the amount of Three Million Six Hundred Seventy Eight Thousand Pesos (P3,678,000.00) shall be in accordance with DBM Budget Circular No. 2023-1, dated November 10, 2023, on the Guidelines on the Grant of the Collective Negotiation Agreement (CNA) Incentive for FY 2023;
2. The appropriation for the following account should be properly classified to specific Object of Expenditure and account code in accordance with COA Circular No. 2015-009 dated December 1, 2015, on Prescribing the Revised Chart of Accounts for LGUs:

RESOLVED FURTHER, to require the Municipality of Cordon, Isabela to comply with the herein review findings and/or conditions and notify this body of actions taken thereon.

RESOLVED FURTHERMORE, to inform the Municipality of Cordon, Isabela that this review action does not authorize any item of appropriation that is/are specifically prohibited by or inconsistent with the provisions of law, and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting and auditing rules and regulations.
