**WHEREAS**, Ordinance No. 05-2023, an Ordinance authorizing Supplemental Budget No. 01 S. 2023 of the Municipality of Ramon, Isabela involving the amount of **FOURTEEN MILLION FOUR HUNDRED THIRTY-SIX THOUSAND SIX HUNDRED SIXTEEN PESOS AND 83/100 (P14,436,616.83)** from the Tax Revenue Excess Over Estimate on Actual Collection in the amount of Nine Million One Hundred Seventy Thousand Three Hundred Thirty Pesos and 47/100 (P9,170,330.47) and Savings from unfilled vacant positions and Savings from Capital Outlay with the total amount of Five Million Two Hundred Sixty Six Thousand Two hundred Eighty Six Pesos and 36/100 (P5,266,286.36) for various expenditures, was submitted to this Sanggunian for review pursuant to the

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

**RESOLVED**, to declare Appropriation Ordinance No. 05-2023 of the Municipality of Ramon, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of R.A No. 7160, and subject further to the following conditions:

1. The Utilization of the Appropriation for Other Professional Services amounting to Five Million Nine Hundred Thirty Thousand Pesos (P 5,930,000.00), shall be in accordance with COA Circular No. 2015-009 dated December 1, 2015, on the Description of Accounts under the Revised Chart of Accounts for Local Government Units;
2. That all procurement activities shall be governed by the provisions of Republic Act No. 9184, the Government Procurement Reform Act (GPRA) and its 2016 Revised Implementing Rules and Regulations

**RESOLVED FURTHER**, to inform the Municipality of Ramon, Isabela that this review action does not authorize any item of appropriation that is/are specifically prohibited by or inconsistent with the provisions of law, and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting and auditing rules and regulations.

**RESOLVED FINALLY**, to furnish a copy of this Resolution to the **Honorable JESUS D. LADDARAN**, Municipal Mayor, and to the Sangguniang Bayan of the Municipality of San Isidro, Isabela through the **Honorable DENNIS JON DELA CRUZ**, Municipal Vice-Mayor.
