ALBANO III TO SIGN ON BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT FIELD OFFICE 02, THE CITY GOVERNMENT UNIT OF ILAGAN, ISABELA, AND THE FOOD AND AGRICULTURE ORGANIZATION OF THE UNITED NATIONS FOR THE IMPLEMENTATION OF THE RISK RESILIENCY PROGRAM THRU CASH-FOR-WORK AND TRAINING**

**WHEREAS**, the Provincial Government of Isabela is committed to upholding the Isabeleño's constitutional rights to life and property by addressing, among others, the root causes of vulnerabilities to disasters, strengthening the province's institutional capacity for disaster risk reduction and management, and building the disaster resilience of local communities to disasters including climate change impacts;

**WHEREAS**, the Department of Social Welfare and Development is the executive department of the Philippine Government responsible for the protection of the social welfare of rights of Filipinos and to promote the social development. It plays a pivotal role in providing meaningful assistance to the people, especially the poor and underserved, thereby ensuring their welfare and well-being;

**WHEREAS**, the Department of Social Welfare and Development Field Office 02 is a sub-office of the Department of Social Welfare and Development that is tasked to implement the latter's programs and projects in Region 02;

**WHEREAS**, consistent with its powers and duties, the Department of Social Welfare and Development has devised the Risk Resiliency Program thru Cash-for-Work and Training, with the aim of strengthening the resilience, adaptive capacity, response capabilities, and food security of the poor, vulnerable, and marginalized families from the impact of climate-related hazards and disasters by providing them with additional income support;

**WHEREAS**, the Food and Agriculture Organization of the United Nations is a specialized agency of the United Nations that leads international efforts to defeat hunger and improve nutrition and food security. Its primary goal is to achieve food security for all and make sure that people have regular access to enough high-quality food to lead active, healthy lives;

**WHEREAS**, the City Government of Ilagan, Isabela is a duly created local government unit exercising administrative powers over the city of Ilagan, Isabela which falls under the jurisdiction of the Provincial Government of Isabela;

**WHEREAS**, the city of Ilagan, Isabela has been selected as a beneficiary of the Risk Resiliency Program thru Cash-for-Work and Training of the Department of Social Welfare and Development;

**WHEREAS**, the success of the program requires close collaboration between the Department of Social Welfare, the Provincial Government of Isabela, the City Government of Ilagan, Isabela, and the United Nations Food and Agriculture Organization, underscoring the importance of multi-stakeholder partnerships in achieving disaster resilience and sustainable development goals;

**WHEREAS**, the collaboration between these agencies was manifested through a Memorandum of Agreement, which is submitted for the review and approval of this August Body;

**WHEREAS**, after careful review, this August Body has determined the MOA to be just and lawful, the responsibilities of the parties, especially the Provincial Government of Isabela, to be proper and consistent with state policies on public welfare and disaster resiliency. As such, this August Body agreed that granting the Honorable Governor the necessary authority to sign such MOA on behalf of the Provincial Government of Isabela to be beneficial and advances the well-being of the Isabeleños;

**WHEREAS**, Section 465(b)(1)(vi) of R. A. No. 7160 empowers the Provincial Governor to represent the Province in all its transactions and sign on its behalf all contracts and such other documents upon the issuance of an authority by the Sangguniang Panlalawigan;

**WHEREFORE**, upon motion of the Honorable Victor G. Dy, duly approved and seconded in a session duly assembled, it was –

**RESOLVED, AS IT HEREBY RESOLVES TO PASS A RESOLUTION AUTHORIZING HONORABLE GOVERNOR RODOLFO T.
