**WHEREAS**, Appropriation Ordinance No. 2023-005, an Ordinance approving Supplemental Budget No. 4 of the Municipality of Roxas, Isabela for Calendar Year 2023, in the amount **THIRTEEN MILLION SEVEN HUNDRED EIGHTY SIX THOUSAND EIGHT HUNDRED FIFTY TWO PESOS & 57/100 (P13,786,852.57)** derived from the FY 2022 Savings of the Local Government of Roxas, Isabela, was submitted to this Sanggunian for review, pursuant to the provisions of Section 327 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

1. That the appropriation for the following account should be properly classified to specific Object of Expenditures and Account Code in accordance with COA Circular No. 2015-009 dated December 1, 2015, on Prescribing the Revised Chart of Accounts for LGUs:

2. That all procurement activities must be governed by the provisions of Republic Act No. 9184, the Government Procurement Reform Act (GPRA) and its Implementing Rules and Regulations.

**RESOLVED FURTHER**, to require the Municipality of Roxas, Isabela to comply with the herein conditions.

**RESOLVED FURTHERMORE**, to inform the Municipality of Roxas, Isabela that this review action does not authorize any item of appropriation that is/are specifically prohibited by or inconsistent with the provisions of law, and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting and auditing rules and regulations.

**RESOLVED FINALLY**, to send a copy of this Resolution to the Sangguniang Bayan of the Municipality of Roxas, Isabela through the **Honorable JONATHAN JOSE C. CALDERON**, Municipal Mayor.
