WHEREAS, Appropriation Ordinance No. 2023-10, an Ordinance authorizing Supplemental Budget No. 09 of the Municipality of Benito Soliven, Isabela for Calendar Year 2023 involving an amount of **NINE HUNDRED FIFTY THOUSAND PESOS (P950,000.00)** derived from the actual collection in excess of estimated income for FY 2023 to supplement fund for regular operation of the Office of the Mayor and Treasurer of the Municipal Government of Benito Soliven, Isabela, was submitted to this Sanggunian for review, pursuant to the provisions of Section 327 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 2023-10 of the Municipality of Benito Soliven, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of Republic Act No. 7160 and subject further to the following condition:

1. All procurement activities shall be governed by the provisions of Republic Act No. 9184, the Government Procurement Reform Act (GPRA) and its Implementing Rules and Regulations;

RESOLVED FURTHER, to require the Municipality of Benito Soliven, Isabela to comply with the herein review finding and/or condition and notify this body of actions taken thereon.

RESOLVED FURTHERMORE, to inform the Municipality of Benito Soliven, Isabela that this review action does not authorize any item of appropriation that is/are specifically prohibited by or inconsistent with the provisions of law, and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting and auditing rules and regulations.

RESOLVED FINALLY, to furnish a copy of this Resolution to the **Honorable ROBERTO T. LUNGAN**, Municipal Mayor, and to the Sangguniang Bayan of the Municipality of Benito Soliven, Isabela through **Honorable JOHN PAUL S. AZUR**, Municipal Vice Mayor.
