**WHEREAS**, Appropriation Ordinance No. 2023-1354, an Ordinance authorizing the Supplemental Budget No. 6 for CY 2023 of the Municipality of San Mariano, Isabela in the amount of **FIVE HUNDRED THOUSAND PESOS (P500,000.00)** out of the unappropriated ending balance of Supplemental Budget No. 03 embodied in the Municipal Appropriation Ordinance No. 2023-1128 under the Local Economic Enterprise (LEE) for the Soil Boring Test for the new public market of the Local Government of San Mariano, Isabela was submitted to this Sanggunian for review pursuant to the provisions of Section 327 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**RESOLVED**, to declare Appropriation Ordinance No. 2023-1354 (Supplemental Budget No. 6 CY 2023) of the Municipality of San Mariano, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of Republic Act No. 7160, and subject further to the following condition:

1. All procurement activities shall be governed by the provisions of Republic Act No. 9184, the Government Procurement Reform Act (GPRA) and its Implementing Rules and Regulations;

**RESOLVED FURTHER**, to require the Municipality of San Mariano, Isabela to comply with the herein review findings and/or conditions and notify this body of actions taken thereon.

**RESOLVED FURTHER**, to inform the Municipality of San Mariano, Isabela that this review action does not authorize any item of appropriation that is/are specifically prohibited by or inconsistent with the provisions of law, and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting and auditing rules and regulations.
