A RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR, THE HONORABLE RODOLFO T. ALBANO III, TO SIGN ON BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA A MEMORANDUM OF AGREEMENT WITH THE PALANAN RURAL HEALTH UNIT AND BIRTHING CENTER FOR THE ESTABLISHMENT OF PARTNERSHIP AND REFERRAL SYSTEM

WHEREAS, it is the policy of the Provincial Government of Isabela to promote the health of its people and to ensure that Isabeleños can avail themselves of healthcare services that are quality and accessible services;

WHEREAS, in accordance with the provisions outlined in Republic Act No. 11223, also known as the Universal Health Care Act, the Provincial Government of Isabela aims to develop effective referral systems and coordination mechanisms between rural health and birthing centers, as well as higher-level healthcare facilities. This initiative seeks to guarantee that individuals in need of specialized medical attention or emergency services can be efficiently referred and transferred to suitable healthcare facilities;

WHEREAS, that the PGI and the local government unit of Palanan, Isabela stands in full support with the Palanan Rural Health Unit and Birthing Center's commitment to delivering excellent healthcare services to its residents;

WHEREAS, the Palanan Rural Health Unit and Birthing Center, managed by LGU of Palanan, Isabela, lacks complete basic laboratory equipment for providing laboratory and x-ray services, thus it is seeking assistance from the PGI to offer these services to its patients through an established referral system.

WHEREAS, recognizing the importance of accessible healthcare in the province, this body supports the Palanan Rural Health Unit and Birthing Center by providing x-ray and laboratory services to referred patients.

WHEREAS, the proposed partnership and referral system between the Provincial Government of Isabela and the Palanan Rural Health Unit and Birthing Center aim to fortify their mutual undertaking, fostering enhanced healthcare delivery and improved patient care.

WHEREAS, submitted for review and approval of this August Body is the draft Memorandum Agreement to be executed between the PGI and Palanan Rural Health Unit and Birthing Center which seeks to establish a partnership and referral system for its patients;

WHEREAS, after careful review of the Memorandum of Agreement this Body deems it beneficial and advantageous for the Province to grant the Provincial Governor the necessary authority to sign the Memorandum of Agreement on behalf of the Provincial Government of Isabela;

WHEREAS, Section 465 (b)(1)(vi) of the Local Government Code empowers the Provincial Governor to represent the Province in all its business transactions and sign on its behalf all contracts and such other documents authority of the Sangguniang Panlalawigan;

WHEREFORE, upon motion of the Honorable Emmanuel Joselito B. Añes, duly approved and seconded in a session duly assembled, it was –
