**A RESOLUTION UPHOLDING THE VALIDITY OF ORDINANCE NO. 2021-026 OF THE MUNICIPALITY OF ECHAGUE, ISABELA ENTITLED, "AN ORDINANCE APPROVING THE RECLASSIFICATION OF A PARCEL OF LAND FROM AGRICULTURAL LOT TO RESIDENTIAL LOT WITH AN AGGREGATE AREA OF FIFTEEN THOUSAND THREE HUNDRED NINETY FOUR (15,394) SQ. MTS. MORE OR LESS, SITUATED IN THE BARRIO OF FUGU (ACTUALLY LOCATED IN ANGOLUAN), MUNICIPALITY OF ECHAGUE, PROVINCE OF ISABELA, COVERED AND EMBRACED BY TCT NO. **WHEREAS**, Section 20 (a) of R. A. 7160 or the Local Government Code of 1991 grants a municipality the power to authorize the reclassification of agricultural lands into a residential, commercial or industrial purposes and was more specifically stated as follows:

*"A city or municipality may, through an ordinance passed by the Sanggunian after conducting public hearings for the purpose, authorize the reclassification of agricultural lands and provide for the manner of their utilization or disposition in the following cases: (1) when the land ceases to be economically feasible and sound for*

*agricultural purposes as determined by the Department of Agriculture or (2) where the land shall have substantially greater economic value for residential, commercial, or industrial purposes, as determined by the Sanggunian concerned: Provided, That such reclassification shall be limited to the following percentage of the total agricultural land area at the time of the passage of the ordinance";*

**WHEREAS**, Ordinance No. 2021-026 was enacted by the Sangguniang Bayan of Echague, Isabela, reclassifying a parcel of land covered under Transfer Certificate of Title No. TSC-40238 located in Brgy. Fugu (currently situated in Brgy. Angoluan), Echague, Isabela, with an aggregate land area of 15,394 square meters, more or less from Agricultural to residential purposes;

**WHEREAS**, under MC No. 54, Series of 1993, Section 3, "All ordinances authorizing the reclassification of agricultural lands shall be subject to the review and approval by the province in the case of component city or municipality";

**WHEREAS**, having been authorized to review ordinances reclassifying agricultural lands under the abovesaid Memorandum Circular, the Committee on Housing, Subdivision and Land Use Classification conducted a thorough review of Ordinance No. 2023-026 and finds the same to be in consonance to the mandate of the Sangguniang Bayan pursuant to Section 20 of R.A. No. 7160. Thus, said ordinance is within the purview of the powers conferred by law to their Sangguniang Bayan;

**WHEREAS**, the Committee recommended to the Body to uphold the validity of Ordinance No. 2023-026 of the Municipality of Echague, Isabela;

**NOW THEREFORE**, above premises considered, upon motion of **HON. ED CHRISTIAN S. GO**, duly approved and seconded in a session duly assembled, it was:
