A RESOLUTION AUTHORIZING THE HON. FAUSTINO G. DY III, GOVERNOR PROVINCE OF ISABELA TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE MUNICIPAL LOCAL GOVERNMENT UNIT OF RAMON, ISABELA AND ISABELA POULTRY GROWERS AND MARKETING COOPERATIVE OF CASTILLO, ECHAGUE, ISABELA FOR THE OPERATION OF THE FEEDMILL PROJECT IN RAMON, ISABELA

WHEREAS, in CY 2001 during the term of Governor Faustino S. Dy, Jr., the construction of a feed-mill plant situated in Barangay Aguinaldo, Ramon, Isabela has started for the Magat Resource Fisheries Sustainable Development (MRFSD) Program to cater to the need for timely and cheaper aqua-feeds for fisher-folks towards their increased productivity and income;

WHEREAS, in CY 2005, as contained in the Executive Agenda of the former administration, the Provincial Government of Isabela (PGI) embarked on Tilapia Production and Processing supportive of the government's fisher-folk initiatives under the Geographical Convergence Program;

WHEREAS, to ensure the implementation of Tilapia Production and Processing, the PGI provided the previous administration of Mayor Raymond P. Espidol of Ramon, Isabela, One Million Five Hundred Thousand Pesos (Php1,500,000.00) for the completion of aqua-feed-mill project;

WHEREAS, the above-mentioned amount remained unspent and the aqua-feed mill project was likewise stagnated resulting to the deterioration of the facility; hence, the beneficiary cooperative for the same project has ceased operation since 2006 and its officers already dissolved;

WHEREAS, the Isabela Poultry Growers and Marketing Cooperative (IPGMC), with their managerial capabilities, expertise and support, offered to rehabilitate and operate the aqua-feed-mill project to pursue its original intent which is to provide cheaper aqua-feeds for fisher-folks and to expand its operations by extending its services to livestock growers;

WHEREAS, the MLGU upon learning the interest and intention of IPGMC, expressed its willingness to assist in the rehabilitation of the aqua-feed-mill provided their stake of cheaper feeds for their fisher-folks and household livestock raisers shall be addressed;

WHEREAS, it is an avowed policy of the provincial government to strengthen the cooperative sector and to empower our fisher-folk through measures that harness the entrepreneurial skills of the former while providing cheaper agricultural aqua feeds that would increase the productivity of the latter;

WHEREFORE, upon motion of the **Hon. Ric Justice E. Angobung**, Chairman, Committee on Livelihood and Cooperatives, duly seconded and approved by all the members present in session duly assembled; it was –

RESOLVED AS IT IS HEREBY RESOLVED, to adopt a resolution authorizing the **Hon. Faustino G. Dy III**, Governor Province of Isabela to enter into a Memorandum of Agreement with the **Municipal Local Government Unit of Ramon, Isabela** and **Isabela Poultry Growers and Marketing Cooperative** of Castillo, Echague, Isabela for the operation of the feed-mill project in Ramon, Isabela;

RESOLVED FINALLY, to furnish a copy of this resolution to the Province of Isabela represented by **HON. FAUSTINO G. DY III, GOVERNOR**, to the Municipal Local Government Unit of Ramon, Isabela represented by **HON. WILFREDO L. TABAG, Municipal Mayor**, Ramon, Isabela, and to the **Isabela Poultry Growers and Marketing Cooperative** of Castillo, Echague, Isabela represented by **MR. DIOGENES T. NAGTALON, JR., Chairman, Isabela Poultry Growers Multi-purpose Cooperative** for their information and guidance.
