A RESOLUTION CONFIRMING THE AVAILABILITY OF FUND AS PROVINCIAL GOVERNMENT OF ISABELAS' SHARE TO THE IMPLEMENTATION OF FARM TO MARKET ROADS (FMR) AND BUSINESS PLAN FOR THE ISABELA DAIRY ENTERPRISE THIS CY 2014 UNDER THE PHILIPPINE RURAL DEVELOPMENT PROJECT OF THE DEPARTMENT OF AGRICULTURE (PRDP-DA)

WHEREAS, Republic Act No. 8435, otherwise known as the Agriculture and Fisheries Modernization Act (AFMA) of 1997 sets out the Government's policies in the agriculture sector in attaining equitable distribution of opportunities, income and wealth, expanding productivity and sustaining increase in production of goods and services thereby raising the quality of life of the people, especially the underprivileged;

WHEREAS, the Department of Agriculture (DA) gives foremost consideration to poverty alleviation and social equity through the development and implementation of programs and projects that provide the poor sectors of the community especially those engaged in subsistence agriculture with equitable access to resources, income opportunities, support services and most especially rural infrastructures particularly in areas where productivity is low and the incidence of poverty is high;

WHEREAS, the Province of Isabela through Sangguniang Panlalawigan Resolution No. 069, series of 2014 manifested its interest to avail financing assistance and other support and to participate and authorized the incumbent Provincial Local Chief Executive, **Hon. Faustino G. Dy III**, for and in behalf of the Province of Isabela to appropriate equity required in the Philippine Rural Development Project of the Department of Agriculture (PRDP-DA);

WHEREAS, the Provincial Project Management Implementing Unit of Isabela (PPMIU-Isabela) has for this CY 2014 prepared two (2) projects under the **I-BUILD** - rehabilitation / improvement of Magassi-Union-Camasi Farm to Market Road (FMR) in Cabagan and Tumauni, Isabela and rehabilitation / construction of Olango – Siempre Viva – Trinidad – Manano Farm to Market Road (MFR), Mallig, Isabela and one (1) project under the **I-REAP** – Isabela Dairy Enterprise with a total project cost of **One Hundred Thirty Seven Million Ninety Six Thousand Eight Hundred Fifty Five Pesos and 18/100 (Php137,096,855.18)** that require the Provincial Government of Isabela the amount of **THIRTEEN MILLION ONE HUNDRED NINETY SEVEN THOUSAND ONE HUNDRED THIRTY SIX PESOS & 74/100 (Php13,197,136.74)** as share or counterparts;

WHEREAS, the Local Finance Committee (LFC) has certified the amount of **THIRTEEN MILLION ONE HUNDRED NINETY SEVEN THOUSAND ONE HUNDRED THIRTY SIX PESOS & 74/100 (Php13,197,136.74)** to be available for counterpart to the implementation of the Farm to Market Roads (FMR) and Isabela Dairy Enterprise projects identified this CY 2014 under the Philippine Rural Development Project of the Department of Agriculture (PRDP-DA);

WHEREAS, the Sangguniang Panlalawigan of Isabela through this resolution affirm and confirm the availability of the amount of **THIRTEEN MILLION ONE HUNDRED NINETY SEVEN THOUSAND ONE HUNDRED THIRTY SIX PESOS & 74/100 (P13,197,136.74)** and commit the same as the province' counterpart to the implementation of the Farm to Market Roads (FMR) and Isabela Dairy Enterprise projects identified this CY 2014 under the Philippine Rural Development Project of the Department of Agriculture (PRDP-DA);

WHEREFORE, upon motion of **HON. KIRYLL S. BELLO** duly seconded and approved by all the members present in session duly assembled, it was –

RESOLVED, AS IT HEREBY RESOLVES: TO ADOPT A RESOLUTION AFFIRMING, CONFIRMING AND COMMITTING THE AMOUNT OF **THIRTEEN MILLION ONE HUNDRED NINETY SEVEN THOUSAND ONE HUNDRED THIRTY SIX PESOS & 74/100 (P13,197,136.74)** AS THE PROVINCE' COUNTERPART TO THE IMPLEMENTATION OF THE FARM TO MARKET ROADS (FMR) AND ISABELA DAIRY ENTERPRISE PROJECTS IDENTIFIED THIS CY 2014 UNDER THE PHILIPPINE RURAL DEVELOPMENT PROJECT OF THE DEPARTMENT OF AGRICULTURE (PRDP-DA);

RESOLVED FURTHER, authorizing and empowering the incumbent Provincial Local Chief Executive, **HONORABLE FAUSTINO G. DY III** or his successor, for and in behalf of the Province of Isabela to undertake the above commitments required by **Philippine Rural Development Project of the Department of Agriculture (PRDP-DA)**;

RESOLVED FINALLY, to furnish copy of this resolution to the **HONORABLE GOVERNOR FAUSTINO G. DY III**; **PRDP-DA** thru the **Department of Agriculture, Region 02**, Tuguegarao City, Cagayan, and all other concerned for their information and appropriate action;
