Medical Incident at Brgy. Baligatan, City of Ilagan, Isabela responded by the DART 831 last February 2, 2021. The patient has negative pulse and negative breathing with fully dilated pupils and cold and clammy skin. The patient had also cold and sore throat for two (2) weeks as stated by the significant others. The Emergency Care Assistant conducted continuous Cardiopulmonary Resuscitation (CPR) and the patient was immediately endorsed to GFNDySr. Memorial Hospital.



Team responded to a Medical Incident at Osmeña, City of Ilagan, Isabela last February 5, 2021. Upon interventions, the patient brought to Isabela Doctors General Hospital.







Team responded to a Trauma Incident last February 1, 2021 at San Felipe, City of Ilagan, Isabela. The patient was conscious and coherent and suffered a possible fracture on the left hand. After the Emergency Care Assistants (ECA) interventions, the patient was immediately brought to Isabela GFNDy Sr. Memorial Hospital for proper disposition.



Team responded to a Trauma Incident (Vehicular Incident) at Linglingay, Gamu, Isabela last February 24, 2021, involving a Single Motorcycle. Patient suffered with wounds at his right hand and possible fracture at his left leg. The patient was driving under the influence of alcohol. After immediate interventions, the patient brought to GFNDySr. Memorial Hospital for proper disposition.



Provided Medical Evacuation (MEDEVAC) for a patient undergoing preterm labor with vaginal bleeding and uterine contraction. The patient was transferred from Dr. Victor S. Villaroman Memorial Hospital to Southern Isabela Medical Center last February 3, 2021.



Medical Evacuation (MEDEVAC) for a patient with Posterior Circulation Infarct. The patient was transferred from St. Luke's Medical Center, Metro Manila to Centro 2, Luna, Isabela last February 9, 2021.


