PDRRMO/DART 831 Provided Transport of patient to the patient diagnosed Non-ST elevation Myocardial Infarction, acute coronary syndrome, acute pulmonary congestion, congestive heart failure ischemia, healthcare associated pneumonia, difficulty of breathing and weak in appearance. The patient transferred from Isabela Doctor's General Hospital, Brgy. Alibagu, City of Ilagan, Isabela to Philippine Heart Center, Quezon City last **February 21, 2023**.



Team responded a *Trauma Incident* at Brgy. Dammao, Gamu, Isabela. Involving motorcycle (Euro 125) last **February 06, 2023**. The patient was conscious, abrasion at right knee and foot, avulsion at nose bridge. Driving under influence of alcohol as verbalized by the relatives. After the Emergency Care Assistants (ECA) interventions, the patient was immediately brought to GFNDy Memorial Hospital for proper disposition.



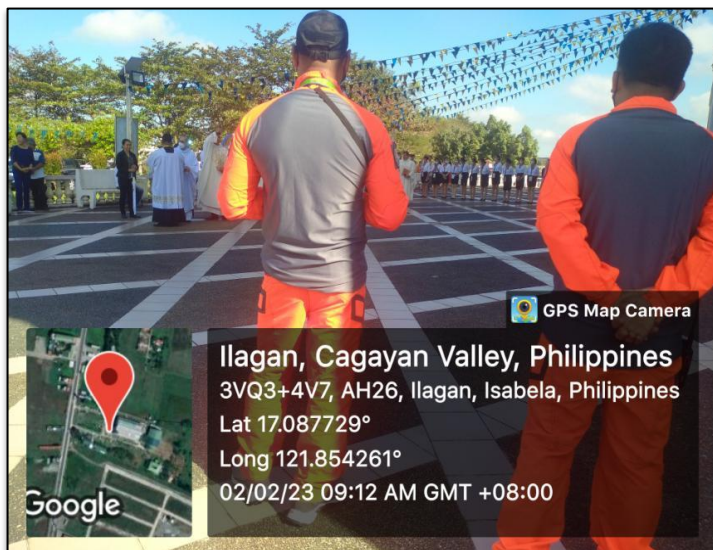
Team responded a *Trauma Incident* at City Homes Subd., Brgy. Alibagu, City of Ilagan, Isabela last **February 19, 2023**. The patient was conscious and coherent, possible fracture on right lower leg with swelling. After the Emergency Care Assistants (ECA) interventions, the patient was immediately brought to Isabela Doctor's General Hospital (IDGH) for proper disposition.



Team responded a **Medical Incident** at City Homes, Alibagu, City of Ilagan, Isabela last **February 10, 2023**. The patient was conscious, pale in appearance, body weakness. Accordingly, he suffered lower back pain with scale of 5/20 and past medical history of hypertension on medication and oosteroarthritis. After the Emergency Care Assistants (ECA) interventions the patient was brought to Governor Faustino N. Dy Sr. (GFNDy) Memorial Hospital for proper disposition.



Team responded a **Medical Incident** at Rosario Street, Bagumbayan, City of Ilagan, Isabela last **February 10, 2023**. The patient was conscious and coherent, body weakness, pale in appearance, anemia. Doctor's Diagnosis: Abnormal uterine bleeding, Blood transfusion (3 bags) from January 12, 2023, February 02, 2023 for admission. After the Emergency Care Assistants (ECA) interventions the patients was brought to Cagayan Valley Medical Center (CVMC) Tuguegarao City, Cagayan Valley for proper disposition.
