Medical Incident happened in Alibagu, City of Ilagan, Isabela responded by the team last September 13, 2020. The patient was suffering from difficulty of breathing and chest pain that radiates to abdomen and shoulder. After the patient's needs were attended, the patient was brought to GFNDy Sr. Memorial Hospital.





Team responded to a Medical Incident happened at Alibagu, City of Ilagan, Isabela last September 19, 2020. Upon the aider's assessments, it was found out that the patient was unable to speak and move his body and suffered from increased of blood pressure. Upon interventions, the patient was brought to GFNDy Memorial Hospital.









Team responded to a Trauma Incident (Vehicular Incident) happened at Alibagu, City of Ilagan, Isabela involving a Honda City aboard with two military. Patient No. 1 was suffered head injury, possible right wrist dislocation and bleeding at the right ear while Patient No. 2 has negative pulse and negative breathing and inflicted the same injuries as the other patient. After immediate interventions the patients was brought to GFNDy Sr. Memorial Hospital.




