### **DECLARATION OF FAILURE OF BIDDING FOR THE SECOND TIME FOR THE PROJECT SUPPLY AND DELIVERY OF GENERATOR SET (DIESEL), INCLUDING INSTALLATION, TESTING AND COMMISSIONING (2<sup>ND</sup> BID)**

**WHEREAS**, the Provincial Government of Isabela (PGI) advertised an Invitation to Apply for Eligibility and to bid for the Supply and Delivery of Generator Set (Diesel), including Installation, Testing and Commissioning (2<sup>nd</sup> Bid)/ITB No. 2023-G-033/Lot 1 for the second time;

**WHEREAS**, the Approved Budget of the Contract amounts to One Million Five Hundred Pesos & 00/100 (P5,000,000.00), Philippine Currency;

**WHEREAS**, advertisement was posted in the PhilGEPS portal last November 6, 2023, PGI Website and in a conspicuous place within the premises of the Provincial Capitol Building of Isabela for seven (7) consecutive days;

**WHEREAS**, there were no bidders that purchased bidding documents and submitted bids on or before the deadline at 10:00 a.m. of November 28, 2023;

**WHEREAS**, Section 35.1 (a) of the Revised IRR of R.A 9184 provides that the Bids and Awards Committee (BAC) shall declare the bidding a failure when no bids are received;

**WHEREAS**, Section 35.5 of the same Act provides that should there occur a second failure of bidding, the Procuring Entity may resort to negotiated procurement as provided for in Section 53.1 of this IRR.;

**NOW, THEREFORE**, We, Members of the BAC hereby RESOLVE, as it is hereby resolved, to recommend the Declaration of a **FAILURE OF BIDDING** for the abovementioned Project for the second time and for the Provincial Government of Isabela to resort to negotiated procurement.
