**DECLARATION OF FIRST FAILURE OF BIDDING FOR THE SUPPLY AND DELIVERY OF FIVE (5) UNITS GENERATOR SET, 100KVA/80KW, SILENT TYPE; 230V, 1 PHASE RPM, 0.8P.F. CONTROLLER AND WITH COMPLETE STANDARD ACCESSORIES (FLEXIBLE PIPE, MUFFLER, BATTERY AND KEYS)**

**WHEREAS**, the Provincial Government of Isabela (PGI) advertised an Invitation to Apply for Eligibility and to bid for the Supply and Delivery of Five (5) Units Generator Set, 100KVA/80Kw, Silent Type; 230V, 1 Phase RPM, 0.8P.F. Controller and With Complete Standard Accessories (Flexible Pipe, Muffler, Battery and Keys);

**WHEREAS**, the Approved Budget of the Contract amounts to Three Million Eight Hundred Fifty Thousand Pesos & 00/100 (₱3,850,000.00), Philippine Currency;

**WHEREAS**, advertisement was posted in the PhilGEPS portal last December 6, 2023, PGI Website and in a conspicuous place within the premises of the Provincial Capitol Building of Isabela for seven (7) consecutive days;

**WHEREAS**, on the deadline of Submission of Bids on December 28, 2023 at 10:00 a.m., there were no bidders that submitted their bids and participated on the scheduled Opening of Bids thereafter at 10:30 a.m.;

**WHEREAS**, Section 35.1 (a) of the Revised IRR of R.A 9184 provides that the Bids and Awards Committee (BAC) shall declare the bidding a failure when no bids are received;

**WHEREAS**, Section 35.2 of the same Act provides that in order to determine the reason for the failed bidding, the BAC shall conduct the mandatory review and evaluation of the terms, conditions and specifications in the Bidding Documents, including its cost estimates;

**WHEREAS**, Section 35.3 of the same Act provides that the (BAC) shall conduct a re-bidding with re-advertisement and/or posting, as provided for in Section 21.2 of the IRR;


