RESOLUTION NO. 2024-6-003

DECLARATION OF FIRST FAILURE OF BIDDING FOR THE SUPPLY AND DELIVERY OF RESCUE PANTS

WHEREAS, the Provincial Government of Isabela (PGI) advertised an Invitation to Apply for Eligibility and to bid for the Supply and Delivery of Rescue Pants;

WHEREAS, the Approved Budget of the Contract amounts to One Million Four Hundred Seventy Thousand Pesos & 00/100 (₱1,470,000.00), Philippine Currency;

WHEREAS, advertisement was posted in the PhilGEPS portal last December 6, 2023, PGI Website and in a conspicuous place within the premises of the Provincial Capitol Building of Isabela for seven (7) consecutive days;

WHEREAS, in response of the advertisement, one (1) Bidder purchased bid documents at the Provincial Treasurer's Office, Capitol, City of Ilagan and the corresponding bid documents for the said project was issued by the BAC Secretariat at the BAC Office, PGSO Building, Alibagu, City of Ilagan, Isabela;

WHEREAS, on the deadline of Submission of Bids, the lone potential bidder was not able to submit its bid;

WHEREAS, Section 35.1 (a) of the Revised IRR of R.A 9184 provides that the Bids and Awards Committee (BAC) shall declare the bidding a failure when no bids are received;

WHEREAS, Section 35.2 of the same Act provides that in order to determine the reason for the failed bidding, the BAC shall conduct the mandatory review and evaluation of the terms, conditions and specifications in the Bidding Documents, including its cost estimates;

WHEREAS, Section 35.3 of the same Act provides that the (BAC) shall conduct a re-bidding with readvertisement and/or posting, as provided for in Section 21.2 of the IRR;

NOW, THEREFORE, We, Members of the BAC hereby RESOLVE, as it is hereby resolved, to recommend the Declaration of a **FAILURE OF BIDDING** for the first time for the abovementioned Project and to REPUBLISH the same for re-bidding.
