**DECLARATION OF FAILURE OF BIDDING FOR THE SECOND TIME FOR THE PROJECT SUPPLY AND DELIVERY OF FIVE (5) UNITS GENERATOR SET, 100KVA/80KW, SILENT TYPE; 230V, 1 PHASE RPM, 0.8P.F. CONTROLLER AND WITH COMPLETE STANDARD ACCESSORIES (FLEXIBLE PIPE, MUFFLER, BATTERY AND KEYS) (2ND BID)**

**WHEREAS**, the Provincial Government of Isabela (PGI) advertised an Invitation to Apply for Eligibility and to bid for the Supply and Delivery of Five (5) Units Generator Set, 100KVA/80Kw, Silent Type; 230V, 1 Phase RPM, 0.8P.F. Controller and With Complete Standard Accessories (Flexible Pipe, Muffler, Battery and Keys) (2<sup>nd</sup> Bid) / ITB No. 2024-G-002;

**WHEREAS**, the Approved Budget of the Contract amounts to Three Million Eight Hundred Fifty Thousand Pesos & 00/100 (₱3,850,000.00), Philippine Currency;

**WHEREAS**, advertisement was posted in the PhilGEPS portal last January 10, 2024, PGI Website and in a conspicuous place within the premises of the Provincial Capitol Building of Isabela for seven (7) consecutive days;

**WHEREAS**, one bidder purchased bidding documents on January 29, 2024;

**WHEREAS**, the prospective bidder was not able to cope up with the deadline of submission of bids or on or before 10:30 a.m. of January 30, 2024;

**WHEREAS**, Section 35.1 (a) of the Revised IRR of R.A 9184 provides that the Bids and Awards Committee (BAC) shall declare the bidding a failure when no bids are received;

**WHEREAS**, Section 35.5 of the same Act provides that should there occur a second failure of bidding, the Procuring Entity may resort to negotiated procurement as provided for in Section 53.1 of this IRR.;

**NOW, THEREFORE**, We, the Members of the BAC hereby **RESOLVE**, as it is hereby resolved, to recommend the Declaration of a **FAILURE OF BIDDING** for the abovementioned Project for the second time and for the Provincial Government of Isabela to resort to negotiated procurement.
