DECLARATION OF FAILURE OF BIDDING FOR THE SECOND TIME FOR THE PROJECT SUPPLY AND DELIVERY OF RESCUE PANTS (2ND BID)

WHEREAS, the Provincial Government of Isabela (PGI) advertised an Invitation to Apply for Eligibility and to bid for the Supply and Delivery of Rescue Pants (2nd Bid) / ITB No. 2024-G-005/Lot 2 for the second time;

WHEREAS, the Approved Budget of the Contract amounts to One Million Four Hundred Seventy Thousand Pesos & 00/100 (₱1,470,000.00);

WHEREAS, advertisement was posted in the PhilGEPS portal last January 23, 2024, at the PGI Website and in conspicuous places within the premises of the Provincial Capitol Building of Isabela for seven (7) consecutive days;

WHEREAS, in response to the advertisement, one (1) bidder purchased bidding documents and submitted bids on or before the deadline at 10:00 a.m. of February 12, 2024;

WHEREAS, the lone bidder passed the preliminary examination of bids using the criterion of non-discretionary "pass/fail";

WHEREAS, the bid of the bidder was evaluated and declared as Single Calculated Bid for its offer of One Million Three Hundred Ninety-Eight Thousand (₱1,398,000.00);

WHEREAS, during the post qualification of the Single Calculated Bidder, its bid was found not responsive as it submitted an Audited Financial Statement where its Business Name differs to what has been registered with the DTI, Mayor's Permit, PhilGEPS and BIR Registration i.e., the registered business name of the bidder per its DTI, Mayor's Permit, PhilGEPS Registration and BIR Registration is **Office Options and General Merchandise**, while the bidder's name in the Audited Financial Statement is **JK2M Builders and Construction Supply Office Options**;

WHEREAS, in view of the abovementioned, the bidder was found not responsive;

WHEREAS, Section 35.1 (c) of the Revised IRR of R.A 9184 provides that the Bids and Awards Committee (BAC) shall declare the bidding a failure when "All bids fail to comply with all the bid requirements or fail post-qualification";

WHEREAS, Section 35.5 of the same Act provides that should there occur a second failure of bidding, the Procuring Entity may resort to negotiated procurement as provided for in Section 53.1 of this IRR.;

NOW, THEREFORE, we, Members of the BAC hereby **RESOLVE**, as it is hereby resolved, to recommend the Declaration of a **FAILURE OF BIDDING** for the abovementioned Project for the second time and for the Provincial Government of Isabela to resort to negotiated procurement.
