**DECLARATION OF FIRST FAILURE OF BIDDING FOR THE PROJECT SUPPLY, DELIVERY, INSTALLATION, TESTING AND COMMISSIONING OF DISASTER ALERT RESCUE AND TRAFFIC MANAGEMENT BROADCAST SYSTEM (TMAS)**

**WHEREAS**, the Provincial Government of Isabela (PGI) advertised an Invitation to Apply for Eligibility and to bid for the Supply, Delivery, Installation, Testing and Commissioning of Disaster Alert Rescue and Traffic Management Broadcast System (TMAS);

**WHEREAS**, the Approved Budget of the Contract amounts to Twenty-Nine Million Pesos & 00/100 (₱29,000,000.00), Philippine Currency;

**WHEREAS**, advertisement was posted in the PhilGEPS portal last April 30, 2024, PGI Website and in a conspicuous place within the premises of the Provincial Capitol Building of Isabela for twenty-one (21) consecutive days;

**WHEREAS**, on the deadline of Submission of Bids on May 20, 2024 at 10:00 a.m., there were no bidders that submitted their bids and participated on the scheduled Opening of Bids thereafter at 10:30 a.m.;

**WHEREAS**, Section 35.1 (a) of the Revised IRR of R.A 9184 provides that the Bids and Awards Committee (BAC) shall declare the bidding a failure when no bids are received;

**WHEREAS**, Section 35.2 of the same Act provides that in order to determine the reason for the failed bidding, the BAC shall conduct the mandatory review and evaluation of the terms, conditions and specifications in the Bidding Documents, including its cost estimates;

**WHEREAS**, Section 35.3 of the same Act provides that the (BAC) shall conduct a re-bidding with re-advertisement and/or posting, as provided for in Section 21.2 of the IRR;

**NOW, THEREFORE**, We, the Members of the BAC hereby RESOLVE, as it is hereby resolved, to recommend the Declaration of a **FAILURE OF BIDDING** for the first time for the abovementioned Project and to REPUBLISH the same for re-bidding.
