**BAC RESOLUTION DECLARING THE FIRST FAILURE OF BIDDING FOR THE PUBLIC AUCTION OF VARIOUS MOTOR VEHICLES AND SCRAPPED MOTOR VEHICLES**

**RESOLUTION NO. PA - 001**

**WHEREAS**, the Provincial Government of Isabela advertised the Invitation to Apply for Eligibility and to Bid for Public Auction of Various Motor Vehicles and scrapped Motor Vehicles for the Province of Isabela on February 4, 2023 and posted the same at the Website of the PGI and in a conspicuous place at the premises of the Provincial Capitol continuously for 7 days;

**WHEREAS**, on February 14, 2023, a Pre-Bid Conference was conducted by the Bids and Awards Committee to thresh out concerns and issues that might arise pertaining to the Public Auction;

**WHEREAS**, during the said conference, however, no prospective bidders attended;

**WHEREAS**, in response to the said advertisement, one (1) Offeror purchased bid documents on February 21, 2023 at the Provincial Treasurer's Office, Capitol, City of Ilagan;

**WHEREAS**, the Offeror submitted its bid before 10:00 A.M. on February 21, 2023;

**WHEREAS**, the Public Auction on February 21, 2023 did not push through as there was only one (1) bidder that submitted a bid;

**WHEREAS**, Commission on Audit Circular No. 89-296 dated January 27, 1989 prescribes the policy guidelines in the conduct of the "divestment or disposal of property and other assets of all government entities/instrumentalities, whether national, local or corporate, including the subsidiaries thereof xxx";

**WHEREAS**, the same circular provides that a failure of bidding occurs when there will only be one offeror, and in that case, the bid of the single offeror shall not be opened;

**NOW, THEREFORE**, We, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**: to **DECLARE** the Public Auction a failure for the first time by virtue of Commission on Audit Circular No. 89-296.

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED: to CANCEL the conduct of the procurement proceedings for ITB No. 2023-G-012 by virtue of the authority granted to it under Section 35.6. of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184.
