NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**;



RESOLVED at the Office of the Bids and Awards Committee, Alibagu, City of Ilagan, Isabela this MAR 06 2023.


