WHEREAS, the Bidder submitted its bid including the legal, technical and financial documents before 10:00 A.M. on February 27, 2023;

WHEREAS, the Bid Opening was conducted on February 27, 2023 at 10:30 A. M. at the Office of the Bids and Awards Committee, PGSO Building, Capitol Compound, Alibagu, City of Ilagan, Isabela;




