WHEREAS, the Provincial Government of Isabela advertised the Invitation to Apply for Eligibility and to Bid for the Supply and Delivery of Hemodialysis Supplies /ITB No. 2023-G-009/Lot 1 for the Province of Isabela on March 29, 2023 posted the same at the PhilGEPS portal and in a conspicuous place at the premises of the Provincial Capitol continuously for 7 days;

WHEREAS, in response to the said advertisement, two (2) Bidders submitted their Letter of Intent and Application for Eligibility on April 17, 2023;

WHEREAS, one (1) bidder purchased bid documents on April 14, 2023 and another one (1) bidder on April 17, 2023 at the Provincial Treasurer's Office, Capitol, City of Ilagan and the corresponding bid documents for the said project were issued by the BAC Secretariat at the BAC Office, PGSO Building, Alibagu, City of Ilagan, Isabela;

WHEREAS, the Bidder submitted their bid including the legal, technical and financial documents before 10:00 A.M. on April 17, 2023;

WHEREAS, the Bid Opening was conducted on April 17, 2023 at 10:30 A. M. at the Office of the Bids and Awards Committee, PGSO Building, Capitol Compound, Alibagu, City of Ilagan, Isabela;

WHEREAS, during the bid opening on April 17, 2023, the bidders passed the preliminary examination, to wit;


