**RESOLUTION NO. 2023 - G - 012**

**WHEREAS**, the Bids and Awards Committee posted an Invitation to Bid for the project Contract for the Collection, Transport, Treatment and Disposal of Pathological Waste/ Medical Waste of the Various Hospitals of PGI in the PhilGEPS, Website of the Provincial Government of Isabela and in three conspicuous places within the premises of the provincial capitol and intends to apply through the General Fund the sum of Four Million Two Hundred Thirty Five Thousand & 00/100 (₱4,235,000.00) being the Approved Budget for the Contract (ABC);

**WHEREAS**, in response to the said advertisement, two (2) Bidders submitted their Letter of Intent and Application for Eligibility on May 8, 2023;

**WHEREAS**, the bidder purchased bid at the Provincial Treasurer's Office, Capitol, City of Ilagan and the corresponding bid documents for the said project were issued by the BAC Secretariat at the BAC Office, PGSO Building, Alibagu, City of Ilagan, Isabela;

**WHEREAS**, the Bidders submitted their bids including the legal, technical and financial documents before 10:00 A.M. on May 8, 2023;

**WHEREAS**, on the scheduled Bid Opening on May 8, 2023 at 10:30 A. M. at the Office of the Bids and Awards Committee, PGSO Building, Capitol Compound, Alibagu, City of Ilagan, Isabela, the bid opening was cancelled as the number of BAC Members present was not sufficient to constitute a quorum;

**WHEREAS**, before the close of business hours on May 8, 2023, the BAC Chairman issued a Notice of Postponement and reset the opening of bids to May 16, 2023;

**WHEREAS**, on May 15, 2023, a special meeting was called to resolve the issue regarding the need to increase the ABC of the contract per instruction of the HoPe;

**WHEREAS**, Section 35.6 of the 2016 Revised IRR of Republic Act No. 9184 authorizes the BAC, upon consultation with the end-user unit, to cancel or terminate the conduct of procurement activities for any justifiable reason;

**WHEREAS**, after due deliberation and consultation with the end-user unit, the Bids and Awards Committee deemed it necessary to cancel the conduct of procurement activities in order to increase the ABC of the contract, which is yet to be determined on a certain date.

**NOW, THEREFORE**, We, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**: to **CANCEL** the conduct of the procurement proceedings for ITB No. 2023-G-012 by virtue of the authority granted to it under Section 35.6. of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184.
