WHEREAS, the Provincial Government of Isabela advertised the Invitation to Apply for Eligibility and to Bid for the Supply and Delivery of Ten (10) Units Rescue Boat, 14 Feet /ITB No. 2024-G-009/Lot 6 for the Province of Isabela on March 11, 2024, posted the same at the PhilGEPS portal and in a conspicuous place at the premises of the Provincial Capitol continuously for 25 days;

WHEREAS, in response to the advertisement, one (1) Bidder purchased bid documents on March 25, 2024 at the Provincial Treasurer's Office, Capitol, City of Ilagan and the corresponding bid documents for the said project was issued by the BAC Secretariat at the BAC Office, PGSO Building, Alibagu, City of Ilagan, Isabela;

WHEREAS, a Supplemental/Bid Bulletin was published on March 14, 2024 for the change of the schedules of the Deadline of Submission of Bids from April 2, 2024 on or before 10:00 am to April 4, 2024 on or before 10:00 am and the Bid Opening from April 2, 2024 at 10:30 am to April 4, 2024 at 10:30 am to give prospective bidders ample time to prepare their bid documents in view of the long holiday i.e. March 27 (half day), 28, 29, 30 & 31, 2024;

WHEREAS, on the deadline of submission of bids on or before 10:00 a.m. of April 4, 2024, one (1) Bidder submitted its Letter of Intent and Application for Eligibility and bid envelope;

WHEREAS, the Bid Opening was conducted on April 4, 2024 at 10:30 A. M. at the Office of the Bids and Awards Committee Office, PGSO Building, Capitol Compound, Alibagu, City of Ilagan, Isabela;
