NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**;



To recommend the award of contract for approval by the **HON. RODOLFO T. ALBANO, III**, Governor to the above stated Single Calculated and Responsive Bidder;


