**WHEREAS**, a Supplemental/Bid Bulletin was published on March 14, 2024 for the change of the schedules of the Deadline of Submission of Bids from April 2, 2024 on or before 10:00 am to April 4, 2024 on or before 10:00 am and the Bid Opening from April 2, 2024 at 10:30 am to April 4, 2024 at 10:30 am to give prospective bidders ample time to prepare their bid documents in view of the long holiday i.e. March 27 (half day), 28, 29, 30 & 31, 2024;

**WHEREAS**, on the deadline of submission of bids on or before 10:00 a.m. of April 4, 2024, one (1) Bidder submitted its Letter of Intent and Application for Eligibility and bid envelope;

**WHEREAS**, the Bid Opening was conducted on April 4, 2024 at 10:30 A. M. at the Office of the Bids and Awards Committee Office, PGSO Building, Capitol Compound, Alibagu, City of Ilagan, Isabela;
