**WHEREAS**, on the deadline of submission of bids on or before 10:00 a.m. of May 3, 2024, one (1) Bidder submitted its Letter of Intent and Application for Eligibility and bid envelope;


**NOW, THEREFORE**, We, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**;
