**WHEREAS**, the Provincial Government of Isabela advertised the Invitation to Apply for Eligibility and to Bid for the Procurement of various goods with ITB Reference No. 2024-G-019 for the Province of Isabela on July 31, 2024, posted the same at the PhilGEPS portal and in a conspicuous place at the premises of the Provincial Capitol continuously for 20 days;

**WHEREAS**, in response to the said advertisement, twelve (12) Bidder purchased bid documents on various dates at the Provincial Treasurer's Office, Capitol, City of Ilagan and the corresponding bid documents for the said projects were issued by the BAC Secretariat at the BAC Office, PGSO Building, Alibagu, City of Ilagan, Isabela;

**WHEREAS**, the same number the bidders submitted their Letter of Intent and Application for Eligibility including the eligibility documents before 10:00 A.M. on August 19, 2024 at the BAC Office, PGSO Building, Alibagu, City of Ilagan, Isabela; on August 19, 2024;

**WHEREAS**, the Bid Opening which was originally scheduled on August 19, 2024 was postponed due to lack of quorum;

**WHEREAS**, a Supplemental Bid/Bulletin was issued for the re-scheduling of the Bid Opening to August 29, 2024 and was posted at the PhilGEPS portal and in a conspicuous place at the premises of the Provincial Capitol;

**WHEREAS**, the Bid Opening pushed through on August 29, 2024 at 10:30 A. M. at the Office of the Bids and Awards Committee, PGSO Building, Capitol Compound, Alibagu, City of Ilagan, Isabela;
