BAC RESOLUTION DECLARING THE LOWEST/SINGLE CALCULATED AND RESPONSIVE BID AND RECOMMENDING APPROVAL

RESOLUTION NO. 2024-G-056

WHEREAS, the Provincial Government of Isabela advertised the Invitation to Apply for Eligibility and to Bid for the Procurement of various goods with ITB Reference No. 2024-G-018 for the Province of Isabela on July 26, 2024, posted the same at the PhilGEPS portal and in a conspicuous place at the premises of the Provincial Capitol continuously for 20 days;

WHEREAS, in response to the said advertisement, 3 Bidders purchased bid documents for Lot 1, Lot 2 – 2 Bidders, Lot 3 – 2 Bidders and Lot 4 – 2 Bidders from July 2, 2024 to August 14, 2024, at the Provincial Treasurer's Office, Capitol, City of Ilagan and the corresponding bid documents for the said projects were issued by the BAC Secretariat at the BAC Office, PGSO Building, Alibagu, City of Ilagan, Isabela;

WHEREAS, eight (8) bidders submitted their Letter of Intent and Application for Eligibility including the eligibility documents before 10:00 A.M. on August 14, 2024 at the BAC Office, PGSO Building, Alibagu, City of Ilagan, Isabela;

WHEREAS, the Bid Opening which was originally scheduled on August 14, 2024 was postponed due to lack of quorum;

WHEREAS, a Supplemental Bid/Bulletin was issued for the re-scheduling of the Bid Opening to September 17, 2024 and was posted at the PhilGEPS portal and in a conspicuous place at the premises of the Provincial Capitol;

WHEREAS, the Bid Opening was conducted on September 17, 2024 at 10:30 A. M. at the Office of the Bids and Awards Committee, PGSO Building, Capitol Compound, Alibagu, City of Ilagan, Isabela;

WHEREAS, during the bid opening on September 17, 2024, the preliminary examination of bids resulted to, as follows:

WHEREAS, upon post-qualification and careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by the bidders with the Single Calculated Bid for Lot 2, 3 and 4, their bids have been found responsive.


