BAC RESOLUTION DECLARING THE LOWEST/SINGLE CALCULATED AND RESPONSIVE BID AND RECOMMENDING APPROVAL

WHEREAS, the Provincial Government of Isabela advertised the Invitation to Apply for Eligibility and to Bid for the Procurement of various goods with ITB Reference No. 2024-G-021 for the Province of Isabela on August 29, 2024, posted the same at the PhilGEPS portal and in a conspicuous place at the premises of the Provincial Capitol continuously for 21 days;

WHEREAS, in response to the said advertisement, 2 Bidders purchased bid documents for Lot 1, Lot 3-1 Bidder, Lot 4-1, Lot 5-1 Bidder and Lot 6-1 Bidder or a total of 6 Bidders from September 18, 2024 to October 2, 2024, at the Provincial Treasurer's Office, Capitol, City of Ilagan and the corresponding bid documents for the said projects were issued by the BAC Secretariat at the BAC Office, PGSO Building, Alibagu, City of Ilagan, Isabela;

WHEREAS, five (5) bidders submitted their Letter of Intent and Application for Eligibility including the eligibility documents before 10:00 A.M. on October 2, 2024 at the BAC Office, PGSO Building, Alibagu, City of Ilagan, Isabela;

WHEREAS, a Supplemental Bid/Bulletin was issued for the rescheduling of the Bid Opening from September 18, 2024 to October 2, 2024

and was posted at the PhilGEPS portal, website of the PGI and in a conspicuous place at the premises of the Provincial Capitol;

WHEREAS, the Bid Opening was conducted on October 2, 2024 at 10:30 A. M. at the Office of the Bids and Awards Committee, PGSO Building, Capitol Compound, Alibagu, City of Ilagan, Isabela;
