**WHEREAS**, in response to the said advertisement, one (1) Bidder purchased bid documents on November 22, 2024 for Lot 1 and one (1) Bidder for Lot 2, at the Provincial Treasurer's Office, Capitol, City of Ilagan and the corresponding bid documents for the said projects were issued by the BAC Secretariat to the prospective bidders at the BAC Office, PGSO Building, Alibagu, City of Ilagan, Isabela;

**WHEREAS**, the bidders submitted their Letter of Intent and Application for Eligibility including the eligibility documents before 10:00 A.M. on November 25, 2024 at the BAC Office, PGSO Building, Alibagu, City of Ilagan, Isabela;

**WHEREAS**, the Bid Opening followed at 10:30am on the same date and was conducted at the Office of the Bids and Awards Committee, PGSO Building, Capitol Compound, Alibagu, City of Ilagan, Isabela;
