WHEREAS, the Provincial Government of Isabela advertised the Invitation for the submission of price quotation for the Supply and Delivery of Five (5) Units Generator Set, 100KVA/80Kw, Silent Type; 230V, 1 Phase RPM, 0.8P.F. Controller and With Complete Standard Accessories (Flexible Pipe, Muffler, Battery and Keys) for the Province of Isabela on June 25, 2024, posted the same at the PhilGEPS portal and in a conspicuous place at the premises of the Provincial Capitol pursuant to the provision of the Implementing Rules and Regulations of R.A. 9184, Par. b)i of Annex "H" or Negotiated Procurement under Two Failed Biddings;

WHEREAS, as required by the IRR of the same Act, the Provincial Government of Isabela invited thee (3) suppliers on June 25, 2024 for negotiation to ensure effective competition;

WHEREAS, in response to the request for quotation, one (1) Supplier submitted its bids in a sealed envelope on or before 10:00 A.M. of July 1, 2024;

WHEREAS, the Bid Opening was conducted on July 1, 2024 at 10:30 A. M. at the Office of the Bids and Awards Committee, PGSO Building, Capitol Compound, Alibagu, City of Ilagan, Isabela;
