WHEREAS, the Provincial Government of Isabela advertised the Invitation for the submission of price quotation for the Supply and Delivery of Bamboo Propagules and Various Seedlings to be used for the Re-Greening of the 60-Km By-pass Highways in the Province /RFQ No. G-004 for the Province of Isabela on December 14, 2024 posted the same at the PhilGEPS portal and in a conspicuous place at the premises of the Provincial Capitol pursuant to the provision of the Implementing Rules and Regulations of R.A. 9184, Par.(b)(i) of Annex "H" or Negotiated Procurement under Two Failed Biddings;
