## RESOLUTION NO. 2024-G-049

RESOLUTION RECOMMENDING THE AWARD OF CONTRACT TO GCMED PHARMACEUTICAL DISTRIBUTOR THROUGH REPEAT ORDER UNDER ALTERNATIVE METHODS OF PROCUREMENT IN THE PROCUREMENT OF MEDICAL SUPPLIES FOR USE BY THE DIFFERENT HOSPITALS OF THE PROVINCIAL GOVERNMENT OF ISABELA.

WHEREAS, as a general rule, all procurement shall be done through competitive bidding except resorting to any of the alternative methods of procurement may be allowed when justified by the conditions in order to promote efficiency and economy;

WHEREAS, Rule XVI Section 51 of R.A 9184, otherwise known as the Government Procurement Reform Act, provides for Repeat Order as an Alternative Method of Procurement of Goods;

**WHEREAS**, Repeat Order is a method of procurement of Goods from the previous winning bidder, whenever there is a need to replenish goods procured under a contract previously awarded through Competitive Bidding;

**WHEREAS**, Section 51 of the IRR provides that this method of procurement shall be resorted to under the following conditions:

- (a) Unit prices of the repeat order must be the same as or lower than those in the original contract: Provided, That such prices are still the most advantageous to the GoP after price verification,
- (b) The repeat order will not result in splitting of contracts, requisitions, or purchase orders, as provided for in Section 54.1 of this IRR;
- (c) Except in cases duly approved by the GPPB, the repeat orders shall be availed of only within six (6) months from the date of the Notice to Proceed arising from the original contract: Provided, That there has been a partial delivery, inspection and acceptance of the goods within the same 6-month period; and
- (d) Repeat orders shall not exceed twenty-five percent (25%) of the quantity of each item in the original contract. In order not to exceed the 25% threshold, the goods under the original contract must be: (i) Quantifiable, (ii) Divisible; and (iii) Consisting of at least four (4) units per item; and

WHEREAS, Annex H of the Revised Implementing Rules and Regulations entitled Consolidated Guidelines for the Alternative Methods of Procurement, Subtitle IV, Par. B provides that upon determination of the need to replenish the goods earlier procured through competitive bidding, the End-User unit shall prepare the necessary Purchase Request for the procurement of additional goods, after a careful study and confirmation of the prevailing market price of the goods to be re- ordered and comparing this with the price of the goods in the original contract, accompanied by the appropriate justification why the re-ordering is being pursued;

WHEREAS, the BAC has determined that all the conditions are present that a repeat order can be undertaken By GcMED Pharmaceutical Distributor for being the awardee of the previous contract dated April 19, 2024.

NOW, THEREFORE, THE BIDS AND AWARDS COMMITTEE RESOLVES AS IT HEREBY RESOLVED, TO RECOMMEND TO THE PROVINCIAL GOVERNMENT OF ISABELA, REPRESENTED BY THE GOVERNOR, HON. RODOLFO T. ALBANO III, THE AWARD OF CONTRACT TO GCMED PHARMACEUTICAL DISTRIBUTOR THROUGH REPEAT ORDER UNDER ALTERNATIVE METHODS OF PROCUREMENT IN THE PROCUREMENT OF MEDICAL SUPPLIES FOR USE BY THE DIFFERENT HOSPITALS OF THE PROVINCIAL GOVERNMENT OF ISABELA PURSUANT TO AND IN ACCORDANCE WITH SECTION 51 OF R.A. 9184;
