**RESOLUTION RECOMMENDING THE PROVINCIAL GOVERNMENT OF ISABELA,  
REPRESENTED BY GOVERNOR RODOLFO T. ALBANO, III, FOR THE  
EMERGENCY PROCUREMENT OF RICE FOR EMPLOYEES OF THE PROVINCIAL  
GOVERNMENT OF ISABELA USE**

**WHEREAS**, on March 9, 2020, the President signed Proclamation No. 922 declaring a State of Public Health Emergency throughout the Philippines upon the recommendation of the DOH following the confirmed local transmission of the novel coronavirus disease (COVID-19);

**WHEREAS**, to address the concern for the declaration of State of Public Health Emergency, a Resolution No. 2020-09-4 was enacted by Sangguniang Panlalawigan declaring the whole Province of Isabela under state of calamity due to the spread of African Swine Fever and 2019 Corona Virus Disease;

**WHEREAS**, to effect responsive, accessible, comprehensive, efficient and immediate response to the needs of the constituents in the province of Isabela, especially in times of disasters and calamities, there is an urgency to procure goods using the Negotiated Method of Procurement;

**WHEREAS**, Rule XVI Section 53.2 of R.A 9184, otherwise known as the Government Procurement Reform Act, provides for Negotiated Procurement as an Alternative Method of Procurement of Goods;

**WHEREAS**, upon review of the urgency to procure, where immediate action is necessary, to restore vital public services, the committee recommends to procure through the Negotiated Method;


**WHEREAS, THE BIDS AND AWARDS COMMITTEE RESOLVES AS IT HEREBY  
RESOLVED TO RECOMMEND THE PROVINCIAL GOVERNMENT OF ISABELA,  
REPRESENTED BY GOVERNOR HON. RODOLFO T. ALBANO, III, FOR THE  
EMERGENCY PROCUREMENT OF RICE FOR EMPLOYEES OF THE PROVINCIAL  
GOVERNMENT OF ISABELA USE PURSUANT TO AND IN ACCORDANCE WITH  
SECTION 53.2 OF R.A. 9184;**
