**RESOLUTION RECOMMENDING TO THE PROVINCIAL GOVERNMENT OF ISABELA, REPRESENTED BY THE GOVERNOR, HON. RODOLFO T. ALBANO, III, THE NEGOTIATED PROCUREMENT OF BLUE GOWN AND FACE SHIELD TO BE AWARDED TO GCMED PHARMACEUTICAL DISTRIBUTOR FOR HOSPITAL USE**

**WHEREAS**, on March 9, 2020, the President signed Proclamation No. 922 declaring a State of Public Health Emergency throughout the Philippines upon the recommendation of the DOH following the confirmed local transmission of the novel coronavirus disease (COVID-19);

**WHEREAS**, to address the concern for the declaration of State of Public Health Emergency, a Resolution No. 2020-09-4 was enacted by Sangguniang Panlalawigan declaring the whole Province of Isabela under state of calamity due to the spread of African Swine Fever and 2019 Corona Virus Disease;

**WHEREAS**, despite government efforts, COVID-19 cases continue to rise, hence, proclamation 1218 was thereafter issued, extending the period of State of Calamity throughout the country for a period of one year, effective September 13, 2021 to September 12, 2022;

**WHEREAS**, to effect responsive, accessible, comprehensive, efficient and immediate response to provide the needs of the constituents in the province of Isabela in order to contain and resolve the spread of the Corona Virus known as Covid-19;

**WHEREAS**, Rule XVI Section 53.2 of R.A 9184, otherwise known as the Government Procurement Reform Act, provides for Negotiated Procurement as an Alternative Method of Procurement of Goods in Emergency Cases;

**WHEREAS**, upon review of the urgency to procure, where negotiated procurement under emergency cases may be resorted to, in case of imminent danger to life or property during a state calamity, the committee recommends to procure through the Negotiated Method;


**NOW, THEREFORE, THE BIDS AND AWARDS COMMITTEE RESOLVES AS IT HEREBY RESOLVED TO RECOMMEND TO THE PROVINCIAL GOVERNMENT OF ISABELA, REPRESENTED BY THE GOVERNOR, HON. RODOLFO T. ALBANO, III, THE NEGOTIATED PROCUREMENT OF BLUE GOWN AND FACE SHIELD TO BE AWARDED TO GCMED PHARMACEUTICAL DISTRIBUTOR FOR HOSPITAL USE IN PURSUANT TO AND IN ACCORDANCE WITH SECTION 53 OF R.A. 9184;**
