**WHEREAS**, to effect responsive, accessible, comprehensive, efficient and immediate response to procure printer to be awarded to Y CUBE ENTERPRISES for Brgy. Caligayan Child Development Center, San Mateo Day Care Center, Brgy. G-K Arcon Child Development Center, Tumauni West Central School, Tumauni, Isabela use, there is a need to procure goods using the Small Value Method of Procurement;

**WHEREAS**, Section 53 of R.A 9184, otherwise known as the Government Procurement Reform Act, provides for Negotiated Procurement whereby the Procuring Entity directly negotiated a contract with a technically, legally and financially capable supplier, contractor or consultant;

**WHEREAS**, Section 53.9 provides for Small Value Procurement of Goods, Infrastructure Projects and Consulting Services, where the amount involve does not exceed the threshold prescribed in Annex "H" of this IRR: Provided, that in case of Goods, the Procurement does not fall under shopping in Section 52 of this IRR;


**WHEREAS**, upon review of the mode and the need to procure, the Committee recommends to procure through the Small Value Procurement Method;
