**RESOLUTION RECOMMENDING THE AWARD OF CONTRACT TO NAGKAISANG MAGSASAKA NG ISABELA AGRICULTURE COOPERATIVE THROUGH EMERGENCY CASES UNDER NEGOTIATED PROCUREMENT IN THE PROCUREMENT OF RICE FOR FOOD ASSISTANCE USE**

**WHEREAS**, on March 9, 2020, the President signed Proclamation No. 922 declaring a State of Public Health Emergency throughout the Philippines upon the recommendation of the DOH following the confirmed local transmission of the novel coronavirus disease (COVID-19);

**WHEREAS**, to address the concern for the declaration of State of Public Health Emergency, a Resolution No. 2020-09-4 was enacted by Sangguniang Panlalawigan declaring the whole Province of Isabela under state of calamity due to the spread of African Swine Fever and 2019 Corona Virus Disease;

**WHEREAS**, despite government efforts, COVID-19 cases continue to rise, hence, proclamation 1218 was thereafter issued, extending the period of State of Calamity throughout the country for a period of one year, effective September 13, 2021 to September 12, 2022;

**WHEREAS**, in response to the current State of Public Health Emergency and State of Calamity, the BAC intends to procure rice to ensure the wellness of households in the Province;

**WHEREAS**, Section 53.2 of the Revised IRR of RA 9184 allows the resort of emergency purchase subject to conditions required by law;

**WHEREAS**, the BAC sees it proper to conduct emergency purchase of drugs and medicines in connection with the public health emergency declared by the President of the Philippines throughout the country and the state of calamity declared by the Governor of the Province throughout the province;


**WHEREAS**, the BAC directly negotiated with a legally, technically and financially capable supplier namely, NAGKAISANG MAGSASAKA NG ISABELA AGRICULTURE COOPERATIVE;


**WHEREAS**, the offer of NAGKAISANG MAGSASAKA NG ISABELA AGRICULTURE COOPERATIVE was found to be responsive and compliant with the requirements set by the BAC;

**NOW, THEREFORE, THE BIDS AND AWARDS COMMITTEE, HEREBY RESOLVES AS IT HEREBY RESOLVED TO RECOMMEND TO THE PROVINCIAL GOVERNMENT OF ISABELA, REPRESENTED BY THE GOVERNOR, HON. RODOLFO T. ALBANO, III, THE AWARD OF CONTRACT THROUGH EMERGENCY CASES UNDER NEGOTIATED PROCUREMENT TO NAGKAISANG MAGSASAKA NG ISABELA AGRICULTURE COOPERATIVE FOR THE PROCUREMENT OF RICE FOR FOOD ASSISTANCE USE PURSUANT TO AND IN ACCORDANCE WITH SECTION 53 OF R.A. 9184;**


