**RESOLUTION RECOMMENDING THE AWARD OF CONTRACT TO MALLIG DAIRY COOPERATIVE THROUGH EMERGENCY CASES UNDER NEGOTIATED PROCUREMENT IN PROCURING BOTTLED PASTEURIZED MILK FOR BRO LUSOG PROGRAM – PGI USE**

**WHEREAS**, to effect responsive, accessible, comprehensive, efficient and immediate response to provide our High Risk Pregnant and Lactating Mothers, Severely Underweight/ Underweight Children, Severely Wasted School Children and Senior Citizens, through Province-wide Supplementary Feeding Program;

**WHEREAS**, those identified beneficiaries are more likely susceptible to diseases and the need for supplementary milk feeding is highly recommended to help boost the immune system of individuals and will eventually help them to be strong, active and healthy especially during this time of pandemic;

**WHEREAS**, Rule XVI Section 53.2 of R.A 9184, otherwise known as the Government Procurement Reform Act, provides for Negotiated Procurement as an Alternative Method of Procurement of Goods in Emergency Cases;

**WHEREAS**, Section 53 of R.A 9184, provides for Negotiated Procurement whereby the Procuring Entity directly negotiated a contract with a technically, legally and financially capable supplier, contractor or consultant;

**WHEREAS**, In Section 53.2 of the 2016 IRR of RA No. 9184, the procuring entity shall be allowed to apply the rules on Negotiated Procurement (Emergency Cases) in any of the following (a) in case of imminent danger to life or property during a state of calamity; (b) when time is of the essence arising from actual or man-made calamities or other causes where immediate action is necessary to prevent damage to or loss of life or property; or (c) to restore vital public services, infrastructure facilities and other public utilities;

**WHEREAS**, in accordance to Section 53.2, upon preparation of the appropriate documents, the BAC directly negotiated with a supplier with technical, legal and financial capability to deliver the goods and to address the emergency;

**WHEREAS**, upon confirmation and ascertainment of the BAC, MALLIG DAIRY COOPERATIVE has immediately confirmed such capability to address the emergency;

**THEREFORE, THE BIDS AND AWARDS COMMITTEE RESOLVES AS IT HEREBY RESOLVED, TO RECOMMEND THE PROVINCIAL GOVERNMENT OF ISABELA, REPRESENTED BY THE GOVERNOR, HON. RODOLFO T. ALBANO, III, THE AWARD OF CONTRACT TO MALLIG DAIRY COOPERATIVE THROUGH EMERGENCY CASES UNDER NEGOTIATED PROCUREMENT IN PROCURING BOTTLED PASTEURIZED MILK FOR BRO LUSOG PROGRAM – PGI USE, PURSUANT TO AND IN ACCORDANCE WITH SECTION 53 OF R.A. 9184;**
