RESOLUTION RECOMMENDING TO THE PROVINCIAL GOVERNMENT OF ISABELA, REPRESENTED BY THE GOVERNOR, HON. RODOLFO T. ALBANO, III, THE ALTERNATIVE METHOD OF PROCUREMENT THROUGH DIRECT CONTRACTING OF RICE FOR PGI (RICE SUBSIDY PROGRAM) USE

WHEREAS, on March 9, 2020, the President signed Proclamation No. 922 declaring a State of Public Health Emergency throughout the Philippines upon the recommendation of the DOH following the confirmed local transmission of the novel coronavirus disease (COVID-19);

WHEREAS, to address the concern for the declaration of State of Public Health Emergency, a Resolution No. 2020-09-4 was enacted by Sangguniang Panlalawigan declaring the whole Province of Isabela under state of calamity due to the spread of African Swine Fever and 2019 Corona Virus Disease;

WHEREAS, despite government efforts, COVID-19 cases continue to rise, hence, proclamation 1218 was thereafter issued, extending the period of State of Calamity throughout the country for a period of one year, effective September 13, 2021 to September 12, 2022;

WHEREAS, Section 11 of R.A. 11321, an Act instituting to Farmers and Fisherfolk Enterprises Development Program of the Department of Agriculture or Sagip Saka Act allows Direct Purchase by National and Local Government Agencies. The law, in order to promote and support farmers and fisherfolk enterprises development, national and local government agencies shall directly purchase agricultural and fishery products from accredited farmers and fisherfolk cooperatives and enterprises. Provided, that said agricultural and fishery and products are necessary in the performance of their respective mandates;

WHEREAS, the procurement by national and local government agencies of said agricultural and fishery products shall be exempt from the application of the bidding process prescribed under relevant government procurement laws;

WHEREAS, under Section 11.2.1 of IRR of R.A. 11321, (A.O. No. 08 of 2019) provides that the Negotiated Procurement shall refer to any of the negotiated modes of procurement, provided, under RIRR of R.A. 9184 and such other rules or guidelines on Negotiated Procurement that may be issued by the GPPB.

WHEREAS, Section 50 of R.A. 9184, otherwise known as the Government Procurement Reform Act, provides for Direct Contracting as an Alternative Method of Procurement of Goods;

WHEREAS, Direct Contracting or single source procurement is a method of procurement of Goods that does not elaborate Bidding Documents and the Supplier is simply asked to submit a price quotation which may be resorted to any of the following conditions: a.) Procurement of Goods of proprietary in nature which can be obtained only from proprietary source;

WHEREAS, upon review of the urgency to procure, where Direct Contracting under Alternative Method of Procurement may be resorted to, where Procurement of Goods of proprietary in nature which can be obtained only from proprietary source, the committee recommends Direct Contracting through the Alternative Method of Procurement;

NOW, THEREFORE, THE BIDS AND AWARDS COMMITTEE RESOLVES AS IT HEREBY RESOLVED TO RECOMMEND TO THE PROVINCIAL GOVERNMENT OF ISABELA, REPRESENTED BY THE GOVERNOR, HON. RODOLFO T. ALBANO, III, THE ALTERNATIVE METHOD OF PROCUREMENT THROUGH DIRECT CONTRACTING IN THE PROCUREMENT OF RICE FOR PGI (RICE SUBSIDY PROGRAM) USE PURSUANT TO SECTION 50 OF R.A. 9184 IN RELATION TO SECTION 11 OF R.A. 11321;
