WHEREAS, Section 53 of R.A 9184, otherwise known as the Govern Procurement Reform Act, provides for Negotiated Procurement whereby the Procentity directly negotiated a contract with a technically, legally and financially casupplier, contractor or consultant;

WHEREAS, in Section 53.2 of R.A 9184, otherwise known as the Government Reform Act, provides for Emergency Cases as a Negotiated Mer Procurement of Goods;

WHEREAS, Emergency Cases is a method of Procurement of Goods resorted to in case of imminent danger to life or property during a state of call when time is of the essence arising from natural or man-made calamities or other where immediate action is necessary to prevent damage to or loss of life or proto restore vital public services, infrastructure facilities and other public utilities;

WHEREAS, in compliance with Section 53.2 of the RIRR, the commit suppliers to participate in the procurement and to submit their respective bid c

**WHEREAS,** upon obtaining the price quotations, the BAC has validated the technical, legal and financial capabilities of supplier to supply and deliver the items to be procured;

WHEREAS, upon confirmation of such capabilities and after due deliberation of the submitted price quotations, the BAC found the offer of DESTINATION ADVENTURE TRAVEL AND TOURS to be the lowest calculated and responsive bid;
