RESOLUTION RECOMMENDING THE AWARD OF CONTRACT TO GCMED PHARMACEUTICAL DISTRIBUTOR WITH PR NO. 100-24-10-D0200 AMOUNTING ₱268,025.52 THROUGH NEGOTIATED PROCUREMENT UNDER EMERGENCY CASES IN THE PROCUREMENT OF DRUGS AND MEDICINES FOR MANUEL A. ROXAS DISTRICT HOSPITAL USE

WHEREAS, Section 53 of R.A 9184, otherwise known as the Government Procurement Reform Act, provides for Negotiated Procurement whereby the Procuring Entity directly negotiated a contract with a technically, legally and financially capable supplier, contractor or consultant;

WHEREAS, in Section 53.2 of R.A 9184, otherwise known as the Government Procurement Reform Act, provides for Emergency Cases as a Negotiated Method of Procurement of Goods;

WHEREAS, Emergency Cases is a method of Procurement of Goods may be resorted to in case of imminent danger to life or property during a state of calamity, or when time is of the essence arising from natural or man-made calamities or other causes where immediate action is necessary to prevent damage to or loss of life or property, or to restore vital public services, infrastructure facilities and other public utilities;

WHEREAS, in compliance with Section 53.2 of the RIRR, the committee invited suppliers to participate in the procurement and to submit their respective bid quotations;

WHEREAS, upon obtaining the price quotations, the BAC has validated the technical, legal and financial capabilities of supplier to supply and deliver the items to be procured;

WHEREAS, upon confirmation of such capabilities and after due deliberation of the submitted price quotations, the BAC found the offer of GCMED PHARMACEUTICAL DISTRIBUTOR to be the lowest calculated and responsive bid;

NOW, THEREFORE, THE BIDS AND AWARDS COMMITTEE, HEREBY RESOLVES AS IT HEREBY RESOLVED TO RECOMMEND TO THE PROVINCIAL GOVERNMENT OF ISABELA, REPRESENTED BY THE GOVERNOR, HON. RODOLFO T. ALBANO III, THE AWARD OF CONTRACT THROUGH NEGOTIATED PROCUREMENT UNDER EMERGENCY CASES TO GCMED PHARMACEUTICAL DISTRIBUTOR FOR THE PROCUREMENT OF DRUGS AND MEDICINES FOR MANUEL A. ROXAS DISTRICT HOSPITAL USE, PURSUANT TO AND IN ACCORDANCE WITH SECTION 53.2 OF R.A. 9184;

RESOLVED, this 9th day of October, 2024 at the Bids and Awards Committee Office, Alibagu, City of Ilagan, Isabela.

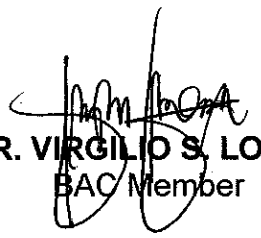
