RESOLUTION RECOMMENDING THE AWARD OF CONTRACT TO ISABELA PROVINCIAL EMPLOYEES MULTI PURPOSE COOPERATIVE WITH PR NO. 100-2024-09-0745 AMOUNTING \$72,000.00 THROUGH SHOPPING UNDER ALTERNATIVE METHODS OF PROCUREMENT IN THE PROCUREMENT OF GROCERY PACKS FOR BATANG ISABELEÑO, SA BAKUNA PROTEKTADO: THEME "KALUSUGAN NG PAMILYA, SUPORTADO NG BAWAT ISA" USE

WHEREAS, as a general rule, all procurement shall be done through competitive bidding except resort to any of the alternative methods of procurement may be allowed when justified by the conditions in order to promote efficiency and economy;

WHEREAS, Rule XVI Section 52.1(b) of R.A 9184, otherwise known as the Government Procurement Reform Act, provides for Shopping as an Alternative Method of Procurement of Goods;

WHEREAS, Shopping is a method of Procurement of Goods whereby the Procuring Entity simply requests for the submission of price quotations for readily available off-the-shelf goods or ordinary/regular equipment to be procured directly from suppliers of known qualifications;

WHEREAS, Section 52.1(b) of the RIRR which provides that the procurement of ordinary or regular office supplies and equipment not available in the Procurement Service involving an amount not exceeding the thresholds prescribed in Annex "H" of this IRR have been complied;

WHEREAS, Section 52.3 of the Revised Implementing Rules and Regulations requires at least three (3) price quotations from bona fide suppliers shall be obtained;

WHEREAS, upon obtaining the price quotations, the BAC has validated the technical, legal and financial capabilities of supplier to supply and deliver the items to be procured;

WHEREAS, upon confirmation of such capabilities and after due deliberation of the submitted price quotations, the BAC found the offer of IGLT SCHOOL & OFFICE SUPPLIES TRADING to be the lowest calculated and responsive bid;

NOW, THEREFORE, THE BIDS AND AWARDS COMMITTEE RESOLVES AS IT HEREBY RESOLVED, TO RECOMMEND TO THE PROVINCIAL GOVERNMENT OF ISABELA, REPRESENTED BY THE GOVERNOR, HON. RODOLFO T. ALBANO III, THE AWARD OF CONTRACT TO IGLT SCHOOL & OFFICE SUPPLIES TRADING THROUGH SHOPPING UNDER ALTERNATIVE METHODS OF PROCUREMENT IN THE PROCUREMENT OF GROCERY PACKS FOR BATANG ISABELEÑO, SA BAKUNA PROTEKTADO: THEME "KALUSUGAN NG PAMILYA, SUPORTADO NG BAWAT ISA" USE, PURSUANT TO AND IN ACCORDANCE WITH SECTION 52.1(b) OF R.A. 9184;
