RESOLUTION RECOMMENDING THE AWARD OF CONTRACT TO NXT-PXL ADVERTISING WITH PR NO. 100-2024-10-0858 AMOUNTING ₱77,800.00 THROUGH SMALL VALUE PROCUREMENT UNDER NEGOTIATED PROCUREMENT IN PROCURING OTHER SUPPLIES FOR PARENT-TEEN TRAIL TRAINING OF TRAINERS USE

WHEREAS, Section 53 of R.A 9184, otherwise known as the Government Procurement Reform Act, provides for Negotiated Procurement whereby the Procuring Entity directly negotiates a contract with a technically, legally and financially capable supplier, contractor or consultant;

WHEREAS, in Section 53.9 of the Revised Implementing Rules and Regulations allows procurement of goods not covered by Shopping under Section 52 of the IRR of RA 9184, where the amount involved does not exceed ₱100,000.00 in the case of 1st Class Province, among others;

WHEREAS, to effect responsive, comprehensive, efficient and immediate response to procure other supplies for Parent-Teen Trail Training of Trainers use, there is a need to procure goods through Small Value Method of Procurement;

WHEREAS, in compliance with Section 53.9 of the RIRR, the committee invited suppliers to participate and to submit their respective bid quotations;

WHEREAS, after evaluating the price quotations, the BAC has validated the technical capability of the selected supplier to supply and deliver the items to be procured;

WHEREAS, after consideration of such capabilities and after due deliberation of the committee, the BAC found the offer of NXT-PXL ADVERTISING to be the most responsive bid;

THE BIDS AND AWARDS COMMITTEE RESOLVES AS IT FINDS IT FIT TO RECOMMEND THE PROVINCIAL GOVERNMENT OF ISABELA AUTHORIZED BY THE GOVERNOR, HON. RODOLFO T. ALBANO III, TO AWARD CONTRACT TO NXT-PXL ADVERTISING THROUGH SMALL VALUE PROCUREMENT UNDER NEGOTIATED PROCUREMENT IN PROCURING OTHER SUPPLIES FOR PARENT-TEEN TRAIL TRAINING OF TRAINERS USE, IN ACCORDANCE WITH SECTION 53.9 OF R.A. 9184;
