RESOLUTION RECOMMENDING THE AWARD OF CONTRACT TO TINGKAD, DIGITAL PRINTING SERVICES WITH PR NO. 100-2024-19-0747 AMOUNTING P57,000.00 THROUGH SMALL VALUE PROCUREMENT UNDER NEGOTIATED PROCUREMENT IN PROCURING VEST WITH PRINT FOR IPHO STAFFUSE

WHEREAS, Section 53 of R.A 9184, otherwise known as the Government Procurement Reform Act, provides for Negotiated Procurement whereby the Procuring Entity directly negotiates a contract with a technically, legally and financially capable supplier, contractor or consultant;

WHEREAS, in Section 53.9 of the Revised Implementing Rules and Regulations allows procurement of goods not covered by Shopping under Section 52 of the IRR of RA 9184, where the amount involved does not exceed IPI, 000,000.00 in the case of 1st Class Province, among others;

WHEREAS, to effect responsive accessible, comprehensive, efficient and immediate response to procure Vest with print use, there is a need to procure goods using the Small Value Method of Procure in an accessible, comprehensive, efficient and immediate response to procure years.

WHEREAS, in compliance with Section 53.9 of the RIRR, the committee invited suppliers to participate in the procurement and to submit their respective bid quotations;

WHEREAS, proposition of the price quotations, the BAC has validated the technical, legal and proposition of supplier to supply and deliver the items to be procured;

WHEREAS upon confirmation of such capabilities and after due deliberation of the submitted pilice quotations, the BAC found the offer of TINGKAD DIGITAL PRINTING SERVICES AND HARDWARE to be the lowest-calculated and responsive bid;

THEREFORE, THE BIDS AND AWARDS COMMITTEE RESOLVES AS IT MEREBY RESOLVED, TO RECOMMEND THE PROVINCIAL GOVERNMENT OF ISABELA, REPRESENTED BY THE GOVERNOR, HON. RODOLFO T. ALBANO III, THE AWARD OF CONTRACT TO TINGKAD DIGITAL PRINTING SERVICES THROUGH SMALL VALUE PROCUREMENT UNDER NEGOTIATED PROCUREMENT IN PROCURING VEST WITH PRINT FOR IPHO STAFF USE, PURSUANT TO AND IN ACCORDANCE WITH SECTION 53.9 OF R.A. 9184;
