RESOLUTION NO. 2024-GS-175-12

RESOLUTION RECOMMENDING THE AWARD OF CONTRACT TO TUMAUNI HIGH VALUE COMMERCIAL CROPS AGRICULTURE COOPERATIVE THROUGH NEGOTIATED PROCUREMENT UNDER COMMUNITY PARTICIPATION OF SECTION 53.12 OF THE REVISED IRR OF RA 9184 IN THE PROCUREMENT OF VARIOUS VEGETABLE SEEDLINGS FOR MARKETING SUPPORT TO COOPERATIVES AND ASSOCIATIONS UNDER THE I-RISE PROGRAM; FOR DISTRIBUTION TO VARIOUS FARMERS/BARANGAYS IN DISTRICT 1 OF THE PROVINCE OF ISABELA USE

WHEREAS, Section 11 of R.A. 11321 or the "Sagip Saka Act" enacted on April 17, 2017, requires National and Local Government Agencies to promote and support farmers and fisher folk enterprises development by directly purchasing agricultural and fishery products from accredited farmers and fisher folk cooperatives and enterprises;

WHEREAS, Section 11 of R.A. 11321, 2nd paragraph, provides that the procurement by national and local government agencies of said agricultural and fishery products shall be exempt from the application of the bidding process prescribed under relevant government procurement laws, provided, that said agencies shall undergo a negotiated procurement under the applicable guidelines of the GPPB;

WHEREAS, The GPPB issued Resolution No. 18- 2021 approving the amendment to Section 53.12 of the 2016 RIRR of RA 9184 and the guidelines for the conduct of community participation in procurement;

WHEREAS, Rule XVI Section 53.12 of R.A 9184, otherwise known as the Government Procurement Reform Act, provides for Community Participation under Negotiated Procurement;

WHEREAS, Section 53.12 of the 2016 revised IRR of RA 9184 provides that:

Community Participation. Where, in the interest of project sustainability or to achieve certain specific social objectives, it is desirable in selected projects, or its components, to call for participation of local communities THROUGH COMMUNITY OR SOCIAL GROUPS, OR MEMBERS THEREOF in the delivery of Goods and Simple Infrastructure Projects, subject to the GUIDELINES issued by the GPPB;

WHEREAS, the abovementioned cooperative is a duly accredited Farmer and Fisher folk Cooperative under IRRR of 11321;

WHEREAS, upon obtaining the price quotations, the BAC has validated, with due diligence, the technical, legal and financial capabilities of supplier to supply and deliver the items to be procured;

WHEREAS, upon confirmation of such capabilities and after due deliberation of the submitted price quotations, the BAC found the offer of cooperative has the single calculated and responsive quotation;

NOW, THEREFORE, THE BIDS AND AWARDS COMMITTEE RESOLVES AS IT HEREBY RESOLVED, TO RECOMMEND THE PROVINCIAL GOVERNMENT OF ISABELA, REPRESENTED BY THE GOVERNOR, HON. RODOLFO T. ALBANO III, THE AWARD OF CONTRACT TO TUMAUNI HIGH VALUE COMMERCIAL CROPS AGRICULTURE COOPERATIVE THROUGH NEGOTIATED PROCUREMENT UNDER COMMUNITY PARTICIPATION OF SECTION 53.12 OF THE REVISED IRR OF RA 9184 IN THE PROCUREMENT OF VARIOUS VEGETABLE SEEDLINGS FOR MARKETING SUPPORT TO COOPERATIVES AND ASSOCIATIONS UNDER THE I-RISE PROGRAM; FOR DISTRIBUTION TO VARIOUS FARMERS/BARANGAYS IN DISTRICT 1 OF THE PROVINCE OF ISABELA USE, PURSUANT TO AND IN ACCORDANCE WITH SECTION 53.12 OF R.A. 9184;

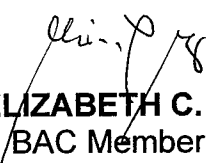

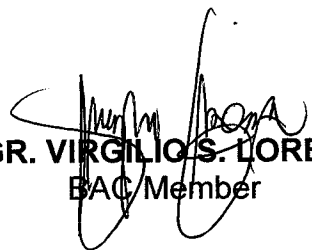
