RESOLUTION RECOMMENDING THE AWARD OF CONTRACT TO BENJ VARIETY STORE WITH PR NO. 100-G-2025-02-0007 AMOUNTING ₱231,200.00 THROUGH SMALL VALUE PROCUREMENT UNDER NEGOTIATED PROCUREMENT IN PROCURING FULL SUBLIMATION POLO SHIRT FOR MUNICIPALITY OF ROXAS USE

WHEREAS, Section 34 of R.A 12009, otherwise known as The Implementing Rules and Regulations of Republic Act No. 12009 or The New Government Procurement Act, provides for Small Value Procurement whereby the Procuring Entity requests for the submission of at least three (3) price quotations for Goods not available in the PS-DBM, Infrastructure Projects, and Consulting Services;

WHEREAS the amount involved does not exceed Two Million Pesos (₱2,000,000.00), subject to the periodic review of the threshold amount;

WHEREAS, to effect responsive, accessible, comprehensive, efficient and immediate response to procure Full Sublimation Polo Shirt for Municipality of Roxas use, there is a need to procure goods using the Small Value Procurement;

WHEREAS, in compliance with Section 34.3(C) of the RIRR, The Committee shall prepare and send the RFQs or RFPs to at least three (3) suppliers, contractors or consultants of known qualifications, as the case may be.;

WHEREAS, after the deadline for submission of quotations or proposals, and Abstract of Quotations or Ratings shall be prepared setting forth the names of those who responded to the RFQ or RFP, and their corresponding price quotations or ratings;

WHEREAS, the BAC shall recommend to the HoPE the award of a contract in favor of the supplier, contractor, or consultant with the LCRB, MEARB, MARB or HRRB;

WHEREAS, upon confirmation of such capabilities and after due deliberation of the submitted price quotations, the BAC found the offer of BENJ VARIETY STORE to be the lowest calculated and responsive bid;

NOW, THEREFORE, THE BIDS AND AWARDS COMMITTEE RESOLVES AS IT HEREBY RESOLVED, TO RECOMMEND THE PROVINCIAL GOVERNMENT OF ISABELA, REPRESENTED BY THE GOVERNOR HON. RODOLFO T. ALBANO III, THE AWARD OF CONTRACT TO BENJ VARIETY STORE THROUGH SMALL VALUE PROCUREMENT UNDER NEGOTIATED PROCUREMENT IN PROCURING FULL SUBLIMATION POLO SHIRT FOR MUNICIPALITY OF ROXAS USE, PURSUANT TO AND IN ACCORDANCE WITH SECTION 34 OF R.A. 12009.
