RESOLUTION RECOMMENDING THE AWARD OF CONTRACT TO FOOD TERMINAL INCORPORATED WITH PR NO. 100-2025-02-0118 AMOUNTING ₱107,250,000.00 THROUGH NEGOTIATED PROCUREMENT UNDER EMERGENCY CASES IN THE PROCUREMENT OF RICE AS RICE ASSISTANCE TO THE FAMILIES AFFECTED BY THE SUCCESSIVE TYPHOONS THAT HIT THE PROVINCE OF ISABELA USE

WHEREAS, as a general rule, all procurement shall be done through competitive bidding, provided that resort to any of the other modes of procurement may be allowed when justified by the conditions in order to promote efficiency and economy;

WHEREAS, Section 35.2 of the Implementing Rules and Regulations (IRR) of R.A. 12009, otherwise known as the New Government Procurement Act, provides for Negotiated Procurement (Emergency Cases) as one of the modes of Procurement consistent with the Fit-for-Purpose procurement approach;

WHEREAS, Section 35.2 of the said IRR states that Emergency Cases is a mode of Negotiated Procurement that may be resorted to in any of the following cases: (a) Imminent danger to life or property during a state of calamity; (b) When time is of the essence arising from natural or man-made calamities; or (c) Other causes where immediate action is necessary: (i) To prevent damage to or loss of life or property, or (ii) To restore vital public services, infrastructure facilities and other public utilities;

WHEREAS, in compliance with Section 35.2.3 of the said IRR, the Head of the Procuring Entity (HoPE) and Governor of the Province of Isabela, Hon. Rodolfo T. Albano III, through Executive Order No. 01, Series of 2025, has delegated to the Bids and Awards Committee (BAC) the authority to directly negotiate with a legally, technically, and financially capable supplier, contractor, or consultant, including the procurement undertaken pursuant to Section 35.2 of the said IRR;

WHEREAS, the BAC has deemed it proper to conduct Negotiated Procurement (Emergency Cases) as an alternative mode of procurement pursuant to Section 35.2 (c) of the IRR of R.A. No. 12009;

WHEREAS, the BAC has found the offer of FOOD TERMINAL INCORPORATED to be responsive and compliant with the preferences of the End-User or Implementing Unit, and has likewise confirmed its legal, technical, and financial capability as a supplier;

NOW, THEREFORE, THE BIDS AND AWARDS COMMITTEE, HEREBY RESOLVES AS IT HEREBY RESOLVED, TO RECOMMEND TO THE PROVINCIAL GOVERNMENT OF ISABELA, REPRESENTED BY THE GOVERNOR, HON. RODOLFO T. ALBANO III, THE AWARD OF CONTRACT THROUGH NEGOTIATED PROCUREMENT (EMERGENCY CASES) TO FOOD TERMINAL INCORPORATED FOR THE PROCUREMENT OF RICE AS RICE ASSISTANCE TO THE FAMILIES AFFECTED BY THE SUCCESSIVE TYPHOONS THAT HIT THE PROVINCE OF ISABELA USE, PURSUANT TO AND IN ACCORDANCE WITH SECTION 35.5 OF THE REVISED IRR
